USES

APPLICATION

Apply one coat only by brush, roller or spray on the clean surface. Hind Mould Release WT after application should be allowed to dry before concreting takes place.

SHELF LIFE

Best before 12 months from the date of manufacture in unopened condition. Should be stored in a cool and dry place away from direct sunlight and naked flame at temperature ranging between 2° C (Min.) and 40 ° C (Max.)

PACKING

100, 200 Litre, HDPE container or as required.
